

For Keyboards with Backlight Option Function:

- Press the key on the top right side with the  symbol to turn on, adjust, and turn off the backlighting feature.
- Press and release the key once to turn the backlight on or off.
- Press and hold the key to adjust the backlight intensity.

Cleaning Instructions for So Cool

- To clean the So Cool Keyboard while it is plugged into the PC, press the left and right Control ("Ctrl") keys together for 2 seconds to lock the keyboard. After cleaning, press both keys again for 2 seconds to unlock keyboard. The LEDs under both Ctrl keys blink when the keyboard is locked.
- Clean the surface of the keyboard by wiping, brushing, spraying or dipping it. Use only rags, sponges or soft bristle brushes.
DO NOT place the USB connector into the fluid.
- Either wipe with dry cloth or allow to air dry.

Recalibrating the Touchpad

- Press and hold the left and right mouse buttons until the two LEDs under the left and the right Ctrl keys blink to recalibrate the touchpad. It takes about two seconds to recalibrate.

- **Phenol based** - Lysol I.C., Beaucoup, Magna Clean, Tek-Trol, etc.
- **Alcohol based** - Cavicide, Isopropyl Alcohol, Medicide, Dürr FD 322, FD 333 and FD 350, etc.
- **Oxidizing** - Hydrogen Peroxide 3% Solution, Lifeguard Series, etc.
- **Quaternary Ammonium** - Roccal-D, Bacto-Sep, Parvosol, Dürr FD 300 2%, Dürr FD 312 2%, etc.
- **Soap and water**
